Significance

Statement Of Significance

20 Riverstone Road, "Cassola" is significant Victorian residence that is representative of the first small farm developments established after the subdivision of Maurice O' Connells estate. The property remained a substantial land holding until the 1970's and functioned first as an orchard and then a farm throughout that time. The property was associated with Joseph Parrington who owned the Riverstone Hotel and the Parington Terraces in the Riverstone Town Centre.

Historical Significance

The property is of historical significance as a remaining substantial home from the small lot subdivision of the Riverstone Estate through the McCulloch Family. The property was also the home of one of the prominent local businessmen and indicates the establishment of Riverstone as a township in the Victorian era.

Criteria b)

Historical Association

Significance

The property has significance at a local level as the original home of Joseph Parrington whose other business interests in Riverstone are noted in the remaining Parrington Terraces.

Criteria c)

Aesthetic/Technical Significance

The property has aesthetic significance as an intact remaining example of a Victorian country home assocaited with a rising middle class in Riverstone in the Victorian Era.

History

Historical Notes or Provenance

The property was part of the initial grant to Maurice O'Connell in 1814 in addition to his original "Riverstone Farm" estate. The land was part of 2960 acres that was subdivided off the Riverstone Estate in 1865 by Andrew McCulloch, whose family subdivided further into small lots in 1881.

The property on which Cassola sits consisting of Lots 19 and 6 of the 1881 subdivision was purchased by Joseph Parrington who had established the Riverstone Hotel and later a group of terraces in the Riverstone Town Centre now known as the Parrington Terraces. Parrington possibly used the property for fruit growing.

Parrington sold the property in 1894 to Henry Edward Wood, a horse breaker who worked at Riverstone. Wood purchased Lots 1-10 and 18 and 19 of the 1881 Subdivision including Parrington's former property. Wood is said to have run training stables on the expanded property. The 1943 and 1961 aerial photo indicates that the wider property was divided into paddocks each with their own stables, which would support this use. By 1970 these had been removed and the land developed for hobby farms.

Wood retained the property until 1943, after which the group of properties passed through a number of hands, used for farming until 1971 when the wider group of properties were sold separately.

Lots 19 and 6 remained together until 1985 and it is likely that the sheds to the rear of No 17 Brighton Street relate to the earlier Cassola property use.

The outbuildings remaining on site at present include a garage to the rear of Cassola House (appears first in the 1961 Aerial photo), a tall timber carport - (appears first in the 1961 Aerial photo), and a row of skillion iron sheds along the rear boundary of Lot 6. (These were present in the 1947 aerial photo)
